### **Rules and Guidelines of the Essay Competition**

#### **1. Eligibility Criteria**

The Competition is open to students who are pursuing their graduate & post graduate in law, M.Com & MBA in any university across the world.

Students of the Institute of Chartered Accounts of India & The Institute of Company Secretaries of India are also eligible to participate. However, those who have completed either their Company Secretary/ Chartered Accountant degrees/courses are not eligible.

The participant must also send a certificate from the Head of the Institution certifying that the candidate is a bonafide student of the University.

#### **2. Theme of the Essay is “e-commerce” with sub-themes for the essay:**

1. E-commerce
2. Digital and electronic Signature
3. Encryption Techniques
4. Liability of Intermediary

#### **3. Guidelines for Submission:**

- 1. Last date of essay submission is August 16, 2016.**
2. The Essay must be written in English.
3. Only one essay per participant may be submitted. Multiple or incomplete submissions will lead to disqualification.
4. Co-Authorship is permitted only up to two authors.
5. The Students who have made a solo entry and as a co-author also will be treated as multiple entries and it will lead to rejection of the second submission. (The entry which is received first will be entertained )
6. Only original essays will be considered for the competition. No part of it should have been published earlier nor should it be under consideration for publication or a contest elsewhere. Any form of plagiarism will result in disqualification of the essay. The participants will submit a separate undertaking with regard to originality of work.
  - **Any Identification mark in any part of the essay is liable to cancellation.**
7. Registration Form(Available in downloadable form on website i.e. <http://laws.puchd.ac.in/show-noticeboard.php>) duly filled and signed by the signed by

the head of the Institution/University and participant must be sent along with the Essay

- **No registration fee.**
- **The Registration form not signed by the head of the Institution/University shall not be considered.**

#### 8. Important Instructions for essay writing and submission:

- Length of the essay and Footnotes:
  - Essay shall consist of an abstract, main text and bibliography.
  - An **abstract not exceeding 200 words** mentioning the title and keywords
  - Essay shall be **no longer than 2000 words**. (Excluding footnotes).
  - Footnotes must conform to **Bluebook (19<sup>th</sup> Edition)** rules of legal citation and must include a description of each authority adequate to allow a reasonable reader to identify and locate the authority in a publication of general circulation
- The essay competition involves written (Hard Copy) and online submissions (both in word document and PDF).
- Format of Electronic Submission:
  - Font size shall **be 12 points in Times New Roman**.
  - 1.5 interlinear space
  - The participant should mention his or her name, address, e-mail id, contact number and name of the college/university with address in the mail and
  - the essay must be sent as an attachment[**in MS word and pdf**] with the Subject **“Essay Competition”**
- Format of Written Hard Copy Submission:
  - Hard copy must be **printed or typed and must not be handwritten**
  - Essay to be printed on one side of **A4 size paper**
  - Cover of written submission: The written submission must have a cover page containing title of the Essay, Name of the Participant, address, e-mail id, contact number and name of the college/university with address.
  - The Cover/envelope should be marked “Essay Competition”.

#### 4. Mode of Submission

Essay must be submitted to the Department of Laws, Panjab University, Sector 14, Chandigarh 160014, latest by August 16, 2016.

Review Criteria

- Entries will be reviewed by a distinguished panel of impartial judges and Academicians.
- Entries will be judged on the basis of originality, style and organization, quality of analysis and quality of research.
- Essays will be judged anonymously
- **Declaration of results: August 20, 2016 (tentative)**
