- 1. Manuscripts, minimum of 3000 words and maximum of 5000 words with proper footnoting and acknowledgements, typed on one side of the paper with 12 font size in Times New Roman, double spaced, with one inch margin on all four sides in MS-Word format, will be accepted.
- 2. Please provide your full name/s, address, designation, email and contact numbers.
- 3. As we follow blind peer review process, therefore the author's name or affiliation should not appear anywhere else in body of manuscript except near the title of the Article.
- 4. Every manuscript should be labelled as: A Research Paper or case comments or book review etc.
- 5. Authors are required to write an abstract (not exceeding 250 words along with 5 keywords) describing the work and its significance.
