

Note: - 1. SC students belong to Punjab whose family income is less than 2.50 lac have to pay Rs. 1235/- as admission fees and also have to submit the Post Metric Shcholarship Form.

- 3. Free education to children of persons killed in November, 1984 riots and terrorist violence in Punjab State.
- 4. Student with Physical Disability (PWD) are exempt from payment of Tuition fees, they have to pay Rs.9680/- as admission fee plus Rs. 1000/- if they are coming from other university.
