(50% in case of SC/ST/Physically & Visually handicapped candidates), 50% marks in LL.B. examination (45% in case of SC/ST/Physically and Visually handicapped candidates) and should have either cleared **UGC NET, CSIR** or should have obtained Ph.D. Degree in the relevant subject

**(ii)** LL.B. degree with at least 55% marks and at least 10 years practice at the Bar/10 years employment experience at officer level with experience of application/enforcement of the relevant branch of Law/10 years' experience as Chartered Accountant. The candidate should not be more than 65 years of age.

The candidates who are already availing JRF scholarships in the University are not entitled for the honorarium but they will be issued experience certificate for the guest faculty.
