#### THEME AND INSIGHT OF THE SEMINAR -

Guru Nanak, a social and legal reformer of 15th.century is remembered and professed today in the context of his teachings on all aspects of society. He has been observed as a saint, a scientist, a sociologist, a psychologist, an environmentalist, a lover of nature, a poet, a writer, a critic of good/bad omens and a great leader. His vision and impact on society is remarkable when he cried for the discrimination on the basis of caste, gender, social and financial status. He was the one who raised his voice against that everything which was demarking discrimination. He taught a simplest way of professing and glancing The All Mighty With The Theory Of One God, No Observance Of Statutes, To Avoid Illusions, To Be Treated With Equality, To Raise Voice Against Wrong Omens, To Respect The One Who Gave You Birth, To Admire The Nature, To Save The Natural Resources, Not To Follow The Misnormers And Misguiders, Not To Be The Deserters From Matrimonial Life, To Avoid Causing Harm To Anyone Closer Or Remorter And Many More. He also suggested a path of discussions and deliberations whenever there is conflict of thoughts on any issues. From his life, many incidences are witnessed where he was found discussing with the then great leaders of religion e.g. pujaris and quazis. He gave importance to all religions. His only inhibition was on the method of observance of religion which according to him was a hindrance to inculcate the value of creating a free and civilised society. He emphasized on equality, equity and secularism violation of which can seek the legal consequence which are also part of our Preamble of constitution. His vision on society and law can be seen in the various sub-themes given above to be deliberated during the sessions of discussion following the teachings of Guru Nanak.

Thus, when the whole world is memorizing the contribution of Guru Nanak on his 550<sup>th</sup> birth anniversary, the department of laws was keen to be a part of this celebration. That's why this initiative is initiated.

- Paper must contain Abstract, five key words, introduction, objective, conclusion and suggestions.
- 2. Paper must contain the following information after the title: full name/s, designation, email, contact number and correspondence address.
- 3. Author is required to take note of
  - (i) Originality of Title
  - (ii) Relevancy, novelty and clarity of idea
  - (iii) Systematic presentation
  - (iv) Conclusion and suggestions.
- 4. The report of plagiarism is to be attached along with the full paper.
- 5. Paper Manuscripts, of 2000 to 2500 words with proper foot noting and acknowledgements, 12 font size in Times New Roman, line spacing 1.5 with one inch margin on all four sides in MS Word format shall be submitted via email at <a href="mailto:seminarlaw@pu.ac.in">seminarlaw@pu.ac.in</a> on or before the deadline.
- 6. Authors are requested to adhere to ILI pattern of Footnoting and Citations.

- 7. The author must certify that paper is his/ her original work and has not been published wholly or partly or accepted for publication elsewhere.
- Participants must also bring duly filled copy of registration forms which is attached with the brochure (subject to the acceptance of their paper) at the time of registration at the registration desk on November 7<sup>th</sup>, 2019 from 08.30 A.M to 09.30 A.M.
- 9. Only one Co-author is allowed.
- 10. No TA/DA will be provided.
- 11. No Registration Fee.
- 12. Last date for the Submission of Paper is November 2<sup>nd</sup> 2019.
