JUDICIAL DEVELOPMENT

Issue Aadhaar, Voter Cards to Sex Workers: SC [BUDHADEV KARMASKAR vs. THE STATE OF WEST BENGAL]

The SC bench led by Justice L. Nageswara Rao said every person is guaranteed their fundamental right irrespective of vocation. "The fundamental rights are guaranteed to every citizen of the country irrespective of his/her vocation. There is a bounden duty on the government, state governments and other authorities are directed to commence the process of issuance of ration card, voter ID cards and Aadhaar cards immediately".

Extended Benefits to Children Orphaned during Covid-19: SC [Re Contagion Of COVID Virus In Children Homes(SMW(c) 4/2020)]

The Division Bench of L. Nageswara Rao and Aniruddha Bose, JJ., addressed that the welfare benefits should be provided not only to the children orphaned by Covid-19 but also to those children who had been orphaned during Covid-19.

"Emphasising over Article 21A, the Bench stated that all children have a constitutional right to free and compulsory elementary education which is guaranteed by the Constitution. Therefore, the State is duty bound and is obligated to facilitate education for children".

Sexual Intent: SC [Attorney General for India versus Satish and another]

The Supreme Court today ruled that "skin to skin" contact is not necessary for a crime to be considered under the Protection of Children from Sexual Offences (POCSO) Act. Calling it a "narrow interpretation of the law", the court set aside a Bombay High Court judgement that had acquitted a man saying, "groping a minor's breast without 'skin to skin contact' can't be termed as sexual assault under POCSO".

LEGISLATIVE DEVELOPMENT

127th Amendment Bill, 2021

The One Hundred and Twenty-Seventh Amendment Bill, 2021 was introduced in Lok Sabha by the Minister of Social Justice and Empowerment, Dr. Virendra Kumar, on August 9, 2021. The Bill amends the Constitution to allow states and union territories to prepare their own list of socially and educationally backward classes.

"The 127th Constitution Amendment Bill amended clauses 1 and 2 of Article 342A and introduced a new clause 3. The Bill also amended Articles 366 (26c) and 338B (9)".

The Farm Laws Repeal Bill, 2021

In view of protests by a group of farmers and in order to take everyone together on the path of inclusive growth and development, the bill was introduced and passed to repeal the three farm laws:-

Farmers (Empowerment and Protection) Agreement on Price Assurance and Farm Services Act, 2020. The Farmers' Produce Trade and Commerce (Promotion and Facilitation) Act, 2020. The Essential Commodities (Amendment) Act, 2020.

The Surrogacy (Regulation) Bill, 2021.

The Bill provides for regulation of surrogacy services in the country, to prohibit the potential exploitation of surrogate mothers and to protect the rights of children born through surrogacy. Key features of the Act:

- -Prohibition and regulation of surrogacy clinics
- -Regulation of surrogacy and surrogacy procedures
- -Written informed consent of surrogate mother
- -Registration of surrogacy clinics
- -Establishment of National Assisted Reproductive Technology and Surrogacy Registry


