### **Scheme of the Quiz:**

- There will be negative marking in each round.
- There will be four rounds: Preliminary, Quarters, Semi-Final and Final.
- There will be Multiple Choice Questions (MCQ's) in Prelims and Quarters.
- In Semi-Finals there will be "Ask the Question Round" and in Finals there will be "Press the Buzzer Round".

### **Rules of the Quiz:**

#### **1. Preliminary Round**

- 40 teams will compete in a preliminary round which will consist of MCQ's comprising 50 questions. Each MCQ will have four options. For every correct answer, the teams will be awarded 4 marks and for every wrong answer, 1 mark will be deducted. The teams will be given exactly 35 minutes to mark their answers.
- 10 teams scoring the highest in the preliminary round will qualify for the quarter-final round. If any team/teams have marks equal to the team in the 10th spot, then they will also qualify for the next round.

#### **2. Quarter Final Round**

- The quarter- final round shall contain 30 questions. Each correct answer will be awarded 10 points and each wrong answer will attract a penalty of 5 points. The teams will be given 20 minutes to mark their answers.
- Five teams will qualify for the Semi-Finals.

#### **3. Semi-Final Round**

- Semi-Finals shall consist of Five teams. Each team will be asked four questions.

##### **A. Original Question**

Every team will have four original questions. They will be awarded 10 points for each correct answer, and 3 points will be deducted for every incorrect answer. No points shall be deducted for passing over a question without answering. Each team will be given 30 seconds to think about the question, failing which the question will automatically pass to the next team in the series.

**B. Passed over Questions:** - 7 points will be awarded for every correct answer, 3 points will be deducted for every wrong answer. No points will be deducted for leaving the question unanswered or for passing it over.

#### **4. Final Round**

The final round shall comprise three finalist teams. This will be a buzzer round. Fifteen questions will be asked in total. Each correct answer will be awarded 20 points. A wrong answer will be penalized with a deduction of 10 points. Tiebreaker question may be asked in case of a tie.

#### **5. Prizes and certificates**

Prizes will be given to the winners and certificates to all the participants.

**Organizers' decision on the quiz shall be final and binding and no correspondence will be entered into regarding the same.**
