

#### I. ABOUT THE DEPARTMENT

#### II. ABOUT COMPETITION COMMISSION OF INDIA

"To promote and sustain an enabling competition culture through engagement and enforcement that would inspire businesses to be fair, competitive and innovative; enhance consumer welfare and supporteconomic growth". The Competition Act, 2002, as amended by the Competition (Amendment) Act, 2007, follows the philosophy of modern competition laws. The Act prohibits anti-competitive agreements, and abuse of dominant position by enterprises and regulates combinations (acquisition, acquiring of control, and M&A), which cause or are likely to cause an appreciable adverse effecton competition within India.

#### **ABOUT THE COMPETITION**

Department of Laws, Panjab University is thrilled to announce the second edition of the CCI-Department of Laws, PU National Moot Court Competition, 2024. This flagship event has been devised with the aim to create an opportunity for learning the development of jurisprudence on emerging trends in competition law, besides armouring the upcoming generations of the legal fraternity with research and oratory skills. The Moot Proposition of the Competition will revolve around Competition Law. In the past, Department of Laws, Panjab University has successfully conducted the first edition of the CCI-Department of Laws, PU National Moot Court Competition in 2022, which witnessed significant participation of law students from all over India.

#### III. ABOUT THE MOOT

Liberalization of the economic policies of the countries around the globe began in the eighties, and in the nineties, the participating countries entered the phase of globalization. The challenges brought with them a wide range of changes in terms of the competitive capabilities of the respective domestic markets. Market-oriented reforms have become crucial both for developed and developing countries to achieve their development and growth goals.

Aim of Competition Policy and Law is to keep such reforms going in a collusive world. Global competitiveness; increased investment; technological capabilities; and consumer welfare are urgently required. Competition policy establishes guidelines for market competition, with macroeconomic goals of growth and stability, and microeconomic goals of producer-consumer welfare. Since then, the Competition Act of 2002 has been effectively implemented in the desired direction. The Act aims to improve consumer welfare and the competitiveness of small businesses in comparison to large corporations. The Act prohibits abuse of dominance, anti-competitive agreements, and unfavorable combinations.

Competition law is a relatively new branch of the law that seeks to promote fair and just business practices. It governs market competition by monitoring for anti-competitive behaviour and ensuring that market participants do not engage in it. Competition law which has evolved on a national level is modern and is thriving with the goal of promoting and maintaining fair-trade practices in domestic markets.

Law schools play an important role in instilling and encouraging the growth of competition law by hosting debates, panel discussions, and moot court competitions, as well as encouraging research and legal writing on the subject. As a result, the Department of Laws at Panjab University proposes to hold a three-day National Moot Court Competition on Competition Law.

#### IV. ABOUT THE FIRST EDITION





The First Edition of the CCI-Dept. of Laws, Panjab University National Moot Court Competition was held successfully in November 2022. The event saw participation from all the prominent law universities and institutes of India. The proposition elicited very erudite and spirited arguments from the various teams and the team from Rajiv Gandhi National University of Law were adjudged the winners. The final was held in the moot court hall of the department and was adjudged by Ms. Payal Malik- Advisor (Eco.), CCI, Mr. Akshay Bhan- Sr. Adv. Panjab and Haryana High Court, Mr. Gautam Shahi- Partner, Dua Associates, Delhi, and Prof (Dr.) Rajinder Kaur- Director, UILS, Panjab University. The 2nd edition promises to be more expansive with enhancements in proposition complexity, competition and general conduct of the same. #### VI. PARTICIPATION GUIDELINES

#### Eligibility Criteria:

- 1. Students enrolled in a full-time Law Degree Programme i.e., Five-Years Integrated Law Degree Programme or Three-Year LL.B. Programme at the time of the competition are eligible to participate in the Competition.
- 2. Each Law College/Law School/Law University shall nominate only one team. Thus, only one team will be eligible to participate from an Institution.
- 3. The approval of the team for participation must be duly signed by the Head of the respective University/Institute/College and must be attached to the registration form.

#### Team Composition:

A team shall be comprised of three members. In each of the oral rounds two members of the team will be speakers and different members of the team can be speakers in different oral rounds. The Teams shall identify the speakers at the beginning of each round.

- Official Language: The official language of the Competition shall be English only.
- Dress Code: The teams are required to follow a strict dress code as prescribed by the Bar Council of India for Advocates.

#### · Format of Competition

- Preliminary Registration
- Memorial Qualifier
- Final Registration
- Preliminary Round I and II
- Quarter-final Round
- Semi-final and Final Rounds
- 1.To confirm their preliminary registration, teams must fill out the registration form and make an initial payment of INR 2500/ (Rupees Two Thousand and Five Hundred Only) on or before the last date of Registration.
- 2. Sixteen teams will qualify the memorial qualifier.
- 3. The teams that qualify the memorial round, thereby advancing, shall be required to make a payment of INR 3500/- (Rupees Three Thousand Five Hundred Only) on or before the last date of Registration. If a team does not submit the required fee by the deadline, the waiting team will have the chance to participate after payment of the registration fee.

#### Registration Procedure

- 2. Duly signed approval letter from the respective institution shall be required as part of the registration process.
- 3. After this initial registration, team codes shall be allotted and communicated on mail provided in the form by the participants.
- 4. Only after filling google form and payment of registration fees, participation of teams shall be confirmed for the memorial qualifier round and the same shall be communicated on the e-mail ID given in the registration form.
- 5. The teams qualifying for the oral rounds shall have to pay a further fee after the declaration of the results of the memorial qualifier round. This fee is inclusive of accommodation.
